**ORDER**

As recommended by the Fourth State Finance Commission and accepted by the Government of Kerala, an amount of Rs. 50 lakh (Rupees Fifty lakh only) has been earmarked under General Sector of Development fund for 2013-14 as Special incentives to best Block Panchayats. As per Government order read as 2<sup>nd</sup> paper above, Vamanapuram, Cherpu and Lalam Block Panchayats have been selected for the first, second and third prizes respectively for the year 2011-12 and the amount of incentive has been ordered vide Government Order read as 3<sup>rd</sup> paper above. Accordingly, Government are pleased to accord sanction to draw and release an amount of Rs. 50,00,000/- (Rupees fifty lakh only) as Special incentive to the award winning Block Panchayats for 2011-12 as detailed below:

2. The Under Secretary, Finance (Accounts) Department will arrange to transfer-credit the amount of Rs. 50,00,000/- (Rupees Fifty lakh only) from the Consolidated Fund to the Public Account of the State at the District Treasury Thiruvananthapuram as detailed at para 1 above.

3. The transfer credit is exempted from all Treasury restrictions.

4. The Commissioner for Rural Development will issue Letter of Authority in form Annexure C-I of the GO read as 1<sup>st</sup> paper above to the Block Panchayats and Treasuries concerned for the release of funds.


