2. One third of the total strength of Personal Assistants will be placed in the Higher Grade. Attenders and Clerical Assistants will be in the ratio of 1:2. A ratio of 1:2 will be maintained between Attender Grade I and II and Clerical Assistants Grade I and II respectively.

3. Personal Assistants (HG) attached to the members of PSC will be eligible for the Special Allowance of Rs.250/- (Rupees Two Hundred and Fifty Only) as admissible to the Personal Assistants attached to Members, PSC with effect from 1.3.2006.
