S. R. O. No. 731/2011.—In exercise of the powers conferred by sub-section (2) of section 8 of the Provident Funds Act, 1925 (Central Act 19 of 1925), the Government of Kerala hereby direct that the provisions of the said Act shall apply to the Provident Fund established for the benefit of the employees of the Kerala Veterinary and Animal Sciences University, which has been added to the Schedule to the said Act.

#### Explanatory Note

(This does not form part of the notifications, but is intended to indicate its general purport.)

As per G.O. (P) No. 454/79/Fin., dated 5th May 1979, the Kerala Agricultural University has been included under the Schedule of sub-section (2) of section 8 of the Provident Funds Act, 1925. The Kerala Veterinary and Animal Sciences University, formed consequent on the bifurcation of the Kerala Agricultural University, is not included under the Schedule of the said Act. The employees of the University are now subscribers to General Provident Fund. The provisions of the Provident Funds Act, 1925 and the rules made thereunder have to be made applicable to the General Provident Fund of the said University. The Government have decided to add the Kerala Veterinary and Animal Sciences University to the list of institutions in the Schedule to the Provident Funds Act, 1925.
