Clarification - Orders Issued.

ORDER

As per Government Order read above clarification on revision of re-employment pay of pensioners was issued. Now it has been noticed that as per Rule 100, Part III, KSRs, minimum of the revised scale of pay of the post held at the time of retirement have to be ensured while fixing re-employment pay in the case of those who retired from a post with pay scales currently not in force and re-employed subsequently and special pay granted in lieu of a separate higher time scale shall be reckoned for the purpose of fixation of re-employment pay.

Hence Government are pleased to issue the following modification to para (i) of Government Order read above.

The re-employment pay of those who retired prior to 01/07/2009 and subsequently re-employed has been revised by merging 64% of Dearness Allowance along with their basic pay at the time of retirement or the corresponding basic pay of 2004 Pay Revision [GO(P) No.145/06/Fin dated 25.03.2006] including special pay in lieu of Higher Time Scale as the case may be, allowing fitment benefit of 12% of the above said basic pay together with special pay and if the calculated value thus arrived is less than the minimum of the corresponding revised scale along with special pay in lieu of Higher Time Scale attached to the post from which the re-employed

pensioner retired, it shall be stepped up to the minimum of the corresponding revised scale of pay of the post held at the time of retirement together with special pay in lieu of Higher Time Scale and the revised re-employed pay will be arrived at by deducting pre revised basic pension from it.


