**ORDER**

Despite various rules and instructions issued by Government for ensuring prompt disbursement of pensionary benefits in respect of employees under State Government, instances of lagging have been noticed in paying off pensionary benefits on account of various reasons. In order to sort out the different issues which cause delay in releasing said benefits, a meeting had been convened under the chairmanship of Chief Secretary. In the meeting, it has been decided to constitute a State level committee for monitoring the prompt disbursement of pensionary claims. Government, after examining the above decision in detail, are pleased to constitute a State level committee comprising of Principal Secretary (Finance) as chairman, Additional Secretary (Pension) as convenor and all major Heads of Departments as members for monitoring the prompt disbursement of pensionary claims.
