**ORDER**

The Subject Committee VIII on Economic Affairs in its Second Report on the Scrutiny of Demands for Grants (12-13) has recommended modification of the existing nomenclature of the Head of Account '2039-00-001-96 – Collectors Fund for Enforcement of Prohibition Policy ( ചാരായ നിരോധനം നടപ്പിലാക്കുന്നതിന് കളക്ടർക്കുള്ള ഫണ്ട് )' as '2039-00-001-96 – Collectors' Fund for Enforcement against Illicit liquor (വ്യാജ മദ്യത്തിനെതിരെ നടപടിയെടുക്കുന്നതിന് കളക്ടർമാർക്കുള്ള ഫണ്ട് )' since the prohibition of arrack has already been enforced in the State.


