ORDER

As per the Government Order read as 1st paper above, the scale of pay and allowance of State Government Employees and Teachers were revised, wherein the post of Dental Hygienist Sr.Grade in Insurance Medical Services Department was given corresponding revision of ₹14620-25280 (pre-revised ₹8390-13270) where as the post of Dental Hygienist Sr.Grade in Health Services Department having the same pre-revised scale was given the revised scale of pay of ₹16180-29180.

Aggrieved by the above, Smt.Beerna Kannu.K, Dental Hygienist Sr.Grade in Insurance Medical Services Department filed O.A No.2480/2012 before the Kerala Administrative Tribunal praying to get the same scale of pay of Dental Hygienist Sr.Grade in Health Services Department ie ₹16180-29180 to the Dental Hygienist Sr.Grade in Insurance Medical Services Department also. In the Order dated 16/01/2013 in the above O.A, the Kerala Administrative Tribunal has directed to consider and pass orders in Annexure-A1, ie the representation filed by the Petitioner dated 03/08/2011 to the Finance Secretary, Government Secretariat, Thiruvananthapuram, in accordance with law after affording an opportunity of being heard to the applicant within 3 months from the date of receipt of copy of the order.

In compliance of the Order, Government heard the petitioner on 18/04/2013.

In earlier Pay Revisions, the scale of pay of all grades of Dental Hygienists in Health Services Department and Insurance Medical Services Department were equal. During Pay Revision 2009 also the scale of pay of Dental Hygienist Grade II and Dental Hygienist Grade I of both the departments are equal. During Pay Revision 2009, all grades of Dental Hygienist in Health Services Department and Insurance Medical Services Department are given normal revision, except Dental Hygienist Sr.Grade in Health Services Department which is given a revision of ₹16180-29180 by

2 level hike. This has resulted in disparity in scale of pay of the post of "Dental Hygienist Sr.Grade" in Health Services Department and Insurance Medical Services Department and needs to be rectified. Hence Government are pleased to modify the scale of pay of the post of Dental Hygienist Sr.Grade in Health Services Department from ₹16180-29180 to ₹14620-25280 equivalent to that of Dental Hygienist Sr.Grade in Insurance Medical Services Department.

The Order of the Kerala Administrative Tribunal in O.A.No.2480/2012 dated 16/01/2013 is complied with accordingly.
