ORDER

As per Government Order read 1st above, Govt. have decided to streamline the procedure of drawal and disbursement of State Life Insurance loans by returning the SLI loan bills of employees to Drawing and Disbursing Officers so as to enter the details in the Service Book and to disburse the amount in order to avoid lapses in deduction of repayment of loan. The Director of Insurance in his letter read as 2nd above has requested to introduce cheque system in the Department instead of Bill system in order to avoid malpractices since events of falsification of bills were noticed. The introduction of cheque system for disbursement of SLI loans and final claim is under active consideration of the Government.

In the circumstances stated above, Government Order read as 1st paper above, stands cancelled and the present procedure shall continue until further orders.


