ORDER

As part of its Fiscal Consolidation efforts, Government order enforcement of the following economy measures for control of non-development expenditure and for enhancing revenue realization, for strict compliance with immediate effect:

- i) No new posts / offices shall be created without the approval of Finance Department.
- ii) E-stamping facility shall be introduced in the Registration Department with immediate effect. Taxes Department will issue detailed orders in this regard.
- iii) All revenue earning Departments should take expeditious decisions on the pending proposals of additional resource mobilization measures and issue orders thereon within a period of one month.
- iv) All revenue earning Departments shall arrange special drives for realization of arrears of revenue due from various sectors. The progress of realization of arrears of revenue shall be reported to Government in the Administrative Department concerned and Finance Department on a monthly basis.

- v) The extent of Administrative Sanctions for works shall be restricted to a maximum of 150% of the available budget provision under the respective heads of account.
