ORDER

As per the Government Order read as 1st paper above, the scale of pay and allowances of State Government Employees and Teachers were revised and according to which the scale of pay of the post of SC Development Officer Grade I of SC Development Department is ₹18740-33680.

Sri.K.L.Paul, SC Development Officer Grade I, Cherpu Block Panchayath filed OA No.2632/2012 before the Kerala Administrative Tribunal raising the grievance that his Junior Sri.K.N.Sasidharan who got promotion as SC Development Officer Grade I on a later date is drawing a basic pay of ₹24040 as on 01/12/2010 whereas the basic pay of the applicant on the same date is only ₹23480.

The Kerala Administrative Tribunal vide order dated 16/01/2013 in the above OA directed the 1st respondent ie, Secretary to Government, Finance Department, to take a decision on Annexure A6 after affording an opportunity of being heard to the applicant within three months from the date of receipt of the same from the second respondent. The request in the Annexure A6 representation is to step up his pay to ₹24040, equivalent to that of his junior, w.e.f 01/12/2010.

In compliance with the said order, Government heard the petitioner on 16/07/2013.

On verification of the documents produced by the applicant at the time of hearing, it is seen that he has filed judicious option as per the conditions in the Pay Revision Order. In the circumstances, since all the conditions under Rule 6, Annexure II of Pay Revision Order are satisfied in this case, Government are pleased to order that the

applicant is eligible for getting step up in pay w.e.f 01/12/2010 ie, the date from which his junior is drawing higher pay. The next increment shall be granted to the applicant after completing the required service of one year from 01/12/2010.
