**ORDER**

According to Rule 8(c) of Part III Kerala Service Rules Military Service other than War Service will count for civil pension subject to conditions mentioned therein. Government Decision No.4 below above rule contemplates that discharge on one's own request from Army Service is not resignation and that Army Service in such circumstances also is reckonable towards subsequent Civil Service subject to the conditions laid down in the rules in Part III Kerala Service Rules, and subject to the refund of pensionary benefits, if any, received by him along with 6% simple interest on the same from the date of receipt till the date of refund.

2. Now it has come to the notice of the Government that those who have prior service in Navy and Air Force are denied of said benefit. Representations have been received in the Government requesting to extend the benefit to other two sections of Armed Forces of Indian Union.

3. Government after detailed examination are pleased to extend the above benefit to personnel discharged from Navy and Air Force and accordingly pleased to substitute the term 'Army Service' mentioned in


Government Decision No.4 under Rule 8(c) Part III Kerala Service Rules with 'Military Service'. These orders will have prospective effect only.
