NOTIFICATION

G. O. (P) No. 406/2013/Fin. Dated, Thiruvananthapuram, 27th August, 2013.

S. R. O. No. 679/2013.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Seventh Amendment) Rules, 2013.

(2) They shall be deemed to have come into force on the 1st day of July, 2009.

2. *Amendment of the Rules.*—In the Kerala Service Rules,—

(a) in Part I,—

(i) in rule 90A, in clause (a), for the letters and figures “Rs. 12930”, “Rs. 4525” and “Rs. 3020”, the letters and figures, “Rs. 22360”, “Rs. 7826” and “Rs. 5220” shall respectively, be substituted;

(ii) in rule 93, in the Exception to clause (ii), for the words, letters, figures and brackets “does not exceed Rs. 10790 in the revised scale of pay ordered in G. O. (P) No. 145/2006/Fin. dated 25th March, 2006”, the words, letters, figures and brackets “does not exceed Rs. 18740 in the revised scale of pay ordered in G. O. (P) No. 85/2011/Fin. dated 26th February, 2011” shall be substituted;

(iii) of rule 103, in clause (b), for the letters and figures “Rs. 8390”, the letters and figures “Rs. 14620” shall be substituted;

(b) in Appendix VII, under the heading, “Section II—Special Casual Leave”, in clause (i) of rule 1, for the letters and figures “Rs. 9190”, the letters and figures “Rs. 16180” shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (P) 407/2011/Fin. dated 26th September, 2011 the Government have enhanced the monetary limits in respect of the ex-gratia allowance for treatment, leave salary, hospital leave and special casual leave, respectively, dealt with in rules 90A, 93 and 103 of Part I and Appendix VII of the Kerala Service Rules, with retrospective effect from 1st July, 2009, consequent to implementation of the IXth Pay Revision as per G. O. (P) No. 85/2011/Fin. dated 26th February, 2011. In order to give statutory validity to the above, the Government have decided to amend the Kerala Service Rules with retrospective effect.

The notification is intended to achieve the above objects.
