**ORDER**

Sri.Joy Oommen, IAS (Rtd) was appointed as Chairman & Managing Director of Kerala Financial Corporation on re-employment basis vide G.O read as 1<sup>st</sup> paper above. Government are pleased to fix the terms and conditions of the appointment of Sri.Joy Oommen as follows :

- 1) His tenure will be for a period of two years from the date of his assumption of charge.
- 2) As Sri.Joy Oommen is a retired officer of Indian Administrative Service, his pay and allowances may be fixed by deducting basic pension + DR from the last pay and allowances drawn at the time of retirement vide G.O read as 3<sup>rd</sup> paper above.
- 3) He will be eligible for re-imbursment of expenses related to shifting of his family to Thiruvananthapuram with house hold goods and also for shifting back to his permanent residence at the end of his tenure.

- 4) He is eligible for residential accommodation to be provided by Kerala Financial Corporation.
- 5) He is eligible for Traveling Allowances as per the rules of Kerala Financial Corporation .
- 6) He is eligible for vehicle facility during his tenure in the Corporation.
- 7) He is eligible for medical facilities as per rules of the Kerala Financial Corporation.
- 8) He is eligible for residential phone and mobile phone and reimbursement of expenditure
- 9) He is eligible for all other allowances admissible in the Kerala Financial Corporation .


