ORDER

As per the Government Order read above, a fuel ceiling was introduced for Secretaries, Heads of Departments and those who are permitted to use vehicles on payment for personal use. Price of fuel has undergone substantial increase over the years. But no revision in accordance with the change in fuel price has been made so far. Government after having examined the matter in detail are pleased to revise the monthly charges to be paid by such officers as follows:

Distance between the place of residence and office	Monthly Fuel Ceiling for each vehicle allowed both for private and official purposes (Litres)	Monthly Charge (₹)
(1)	(2)	(3)
Up to 8 Kms.	100	Monthly Fuel Ceiling X fuel price* at the end of the month X $\frac{6}{100}$ (* Petrol, Diesel or LPG whichever is used in the vehicle)
Over 8 Kms. Up to 12 Kms.	125	
Over 12 kms. Up to 15 Kms.	150	

2. Any excess fuel consumed during a month will have to be paid for by the officer concerned. However travel outside the city for official purposes when circumstances warrant would be outside the ceiling limit.

3. This order comes into effect from 1st October 2013.


