ORDER

As per the Government Order read above, Government ordered additional economy measures on various spheres of Government expenditure. These measures include, among other things, certain restrictions on deputation of officers to field Departments, Public Sector Under takings, autonomous bodies etc.

Government after having reviewed the orders issued in this regard, are pleased to order following amendments to Clause (ii) of the above G.O.

(b) Deleted.

(c) Deputations will be allowed only at the level at which the post was sanctioned originally. When an officer on deputation is promoted to a higher post in his parent Department, he will be reverted back to his parent Department, unless specific orders retaining the officer on deputation even after his promotion are issued by Government on the specific request of the borrowing organization/Department.

(d) No extension of deputation will be allowed in respect of officers/employees who are on deputation at present, otherwise than on sanctioned posts unless the parent department can spare the services of the employee.

(e) Public Sector Undertakings and autonomous bodies will be authorized to recruit personnel with professional qualifications for such posts, viz. administrative, financial and legal functions only with prior permission of the Government.


