ORDER

As recommended by the Fourth State Finance Commission and accepted by the Government of Kerala, an amount of Rs. 900.15 crore is earmarked for General Purpose Fund for the year 2013-14 to the Local Governments, out of which Rs. 25 crore is set apart for Gap Fund from the provision for Grama Panchayats as recommended by the Commission vide para 11.1.4 of the first part of the report of the Fourth State Finance Commission, Kerala. The balance amount of Rs. 875.15 crore is to be distributed to the LGs on a monthly basis (12 instalments starting from April 2013 to March 2014). Tenth instalment of the same for January 2014 is worked out as Rs. 72,92,91,667/- (Rupees Seventy two crore ninety two lakh ninety one thousand six hundred and sixty seven only). Based on the decisions on the recommendations of the Fourth State Finance Commission and various financial adjustments already in position, the following orders are issued:

1. Rs. 72,92,91,667/- (Rupees Seventy two crore ninety two lakh ninety one thousand six hundred and sixty seven only) is sanctioned as the 10th instalment of the General Purpose Fund for 2013-14 to the Local Governments.
2. Rs. 3,20,35,914/- (Rupees three crore twenty lakh thirty five thousand nine hundred and fourteen only) to be transfer credited to the Major head of account '2515-Other Rural Development Programmes' to adjust the salary cost in respect of Engineering staff met by the State Government.
3. Deduct an amount of Rs. 18,722/- (Rupees eighteen thousand seven hundred and twenty two only) being 10th monthly recovery from the provision for Thalanad Grama Panchayat as ordered in the Government Order read as 3rd paper above and transfer credit the same to the head of account '3604 -00-911 Deduct Recoveries'.
4. Deduct an amount of Rs. 6,42,277/- (Rupees six lakh forty two thousand two hundred and seventy seven only) being 10th monthly recovery of excess Gap Fund drawn by five Grama Panchayats as detailed in the statement appended as Annex-I and Annex-II and transfer credit the same to the head of account '3604 -00-911 Deduct Recoveries'.
5. Release the net amount of Rs. 69,65,94,754/- (Rupees sixty nine crore sixty five lakh ninety four thousand seven hundred and fifty four only) to Local Governments as shown in the statements appended as Annex-I and Annex-II.
6. The progressive amount of release of fund to Local Governments for traditional function (General Purpose Fund) during 2013-14 including the release as per this order will be Rs. 729,29,16,670/- (Rupees Seven hundred and twenty nine crore twenty nine lakh sixteen thousand six hundred and seventy only).

7. The Under Secretary, Finance (Accounts) Department will arrange to draw the amount from the District Treasury, Thiruvananthapuram and transfer credit the funds as ordered above.
8. The transfer credit is exempted from all Treasury restrictions.
9. The Local Self Government Department / Controlling Officers/ Sub Controlling Officers will issue Letter of Authority in form Annexure C-I of the GO read as 1st paper above to the Local Governments and to the Treasuries for the release of funds for January, 2014.
