**ORDER**

As per the Government Order read as 2<sup>nd</sup> paper above, National Pension System, (NPS) has been Implemented in the State for all appointments made on or after 1-4-2013 to all the employees to whom part III of Kerala Service Rules are applicable and to all Public Sector Undertakings where pensionary benefits as per Part III of Kerala Service Rules are granted. Several requests were received in Government requesting to retain, those employees whose pre-service training commenced before 31-3-2013 and get appointment thereafter, in the Kerala Service Rules Part III Pension Scheme.

Government, after examining the matter, are pleased to order that, pensionary benefits as per Part III Kerala Service Rules would be made applicable for those employees whose pre-service training had started on or before 31-3-2013 and appointment made on or after 1-4-2013 after the

successful completion of the pre-service training in such departments/  
institutions where pre-service training is mandatory.
