ORDER

As per Government Order read 1st above, Government have issued orders for maintaining, managing and regulating the State Life Insurance Policy of State Government Employees. Vide Government Order read as 2nd paper above, Govt. have issued orders for streamlining the premium payment and revival of SLI/GIS of employees during LWA/Suspension period. Since the State Life Insurance /GIS Policy as a legal document comes under the purview of Indian Contract Act, consent of Insurer and Insured are only necessary in making any amendment in Policy. Drawing and Disbursing Officers or Heads of office do not come under the purview of this contract. Hence, the Director of Insurance in his letter read as 3rd paper above has requested to follow the procedures to revive the policies as existed prior to the order read 2nd above in the case of SLI/GIS policies to facilitate the policy holders in a hassle free manner which would be accountable and authoritative.

Government after having examined the matter in detail are pleased to cancel the GO read as 2nd paper above and order to follow the procedures to revive the policies as existed prior to the order read 2nd above.


