ORDER

As recommended by the Fourth State Finance Commission and accepted by the Government of Kerala, an amount of Rs. 50 lakh (Rupees Fifty lakh only) has been earmarked under General Sector of Development fund for 2013-14 as Special incentives to best Municipalities. As per Government order read as 2nd paper above, Attingal, Malappuram and Kasaragod Municipalities have been selected for the first, second and third prize respectively for the year 2011-12 and the amount of incentive has been ordered vide Government Order read as 3rd paper above. Accordingly, Government are pleased to accord sanction to draw and release an amount of Rs. 50,00,000/- (Rupees fifty lakh only) as Special incentive to the award winning Municipalities for 2011-12 as detailed below:


