ORDER

Government have revised the State Life Insurance premium of State Government Employees as per Government Order 1st cited, as follows.

Pay Range Rate (Revised scales of pay)	Existing rate (relates to old scale)	Enhanced Rate
Basic pay up to Rs.9189/-	Rs.120/-	Rs.150/-
Basic pay from Rs.9190 - 18739/-	Rs.175/-	Rs.225/-
Basic pay from Rs 18740 -29179/-	Rs.300/-	Rs.375/-
Basic pay from Rs.29180/- onwards	Rs.350/-	Rs.450/-

As per G.O 2nd cited, Government have revised the Sum Assured Table and surrender value factor of State Life Insurance Scheme. Now, as per letter read 3rd cited, Director of Insurance has recommended to issue orders to the effect that every fresh SLI policy should be issued only in multiples of ten and minimum of each additional policy should be Rs.100/-. He has also requested that the employees who apply for fresh State Life Insurance Policy should remit the first premium in multiples of ten and should cover the minimum compulsory premium.

Government after having examined the proposal in detail, are pleased to order that every fresh State Life Insurance Policy should be issued only in multiples

of ten covering the minimum compulsory premium and the minimum of each additional policy should be Rs.100/- with effect from 01.01.2014.
