ORDER

As per Government Order read as first paper above, Government have accorded Administrative Sanction for the implementation of e-office project in the Government Secretariat at a total cost of Rs. 300 lakhs in the current financial year. Accordingly necessary steps have been taken in Finance Department to implement e-office and trial run of e office already started in the Department. As per Government order read as second paper above a Departmental Purchase Committee was constituted under the Chairmanship of Secretary (Finance Expenditure) to purchase computers, monitors, scanner (High end and Flat Bed) and laptops and it was decided to purchase the same through M/s. Keltron, Thiruvananthapuram. In the DPC meeting it was also decided to move for one time exemption from the Government order read fourth above and the Store Purchase Department have granted one time exemption vide Government Order read as third above. The Information Technology Department have also concurred the proposal of Finance Department in this regard. M/s. Keltron, Thiruvnanthapuram has forwarded an invoice for Rs. 49,05,360/- for computers and equipments for implementing e-office in Finance Department.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for the purchase of computers and connected equipments for implementing e-office project in Finance Department through M/s Keltron, Thiruvananthapuram at an approximate cost of Rs. 49,05,360/- (Rupees forty nine lakhs five thousand and three hundred sixty only).

Expenditure on this shall be met from the head of account "2052-00-090-90-FD-05- OE- Modernization of Finance Department and Training of Staff (NP) ".
