ORDER

As per the Government Order first read above, Government have ordered that in the case of official residential telephones (with or without STD facility) the maximum number of bi-monthly local calls chargeable to Government account would be 750. Subsequently, internet charges were also included in the purview of official residential telephone charges vide the G.O. second read above.

2. In partial modification of the above orders, Government are pleased to order mobile phone charges also will be brought within the purview of Official Residential Telephone charges for reimbursement subject to the condition that the total bi-monthly call charges inclusive of mobile phone charges shall not exceed the amount equivalent to charges for 750 local calls chargeable to Government account. The excess expenditure, if any, will be borne by the Officer himself.

3. These orders shall take effect from the month of February, 2014.
