ORDER

As per the letter read as 1st paper above, Government of India has released an amount of Rs. 1,22,64,000/- (Rupees One Crore Twenty Two Lakh and Sixty Four Thousand only) towards 2nd instalment of Central assistance for the implementation of DRDA Administration Scheme for the financial year 2014-15. This amount along with the corresponding State Share has to be transferred to the Project Directors of the Poverty Alleviation Units of Pathanamthitta, Alappuzha, Kottayam, Ernakulam, Malappuram, Wayanad, Kannur and Kasaragod.

2. The funding pattern under DRDA Administration Scheme for the financial year 2014-15 is 75:25 between the Centre and the State. Thus, the corresponding State Share comes to be Rs.40,88,000/- (Rupees Forty Lakh and Eighty Eight Thousand only) and the total amount for transfer is Rs.1,63,52,000/- (Rupees One Crore Sixty Three Lakh and Fifty Two Thousand only).

3. Government, after having examined the matter in detail, are pleased to accord sanction for the release of funds to the tune of Rs.1,63,52,000/- (Rupees One Crore Sixty Three Lakh and Fifty Two Thousand only) being the 2nd instalment of Central Share and corresponding State Share for the implementation of the DRDA Administration Scheme

for the financial year 2014-15 to the above Poverty Alleviation Units (DRDAs), as detailed at Annex to this order.

4. The expenditure in this connection will be debited to the head of account as detailed below:-

5. The Under Secretary, Finance (Accounts) Department will arrange to draw the amount from the District Treasury, Thiruvananthapuram and transfer the amount to the Special TSB accounts maintained by the Directors of Poverty Alleviation Units as ordered at Para 3.

6. The release of fund is exempted from all Treasury restrictions.
