ORDER

Government of India in its Sanction Order read as 1st paper above has released an amount of Rs.22,00,00,000/- (Rupees Twenty Two Crore only) as Central Assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State of Kerala for the financial year 2015-16. The amount has to be released to the Kerala State Rural Roads Development Agency.

2. Government, after having examined the matter in detail, are pleased to accord sanction for the release of an amount of Rs.22,00,00,000/- (Rupees Twenty Two Crore only) being Central Assistance under PMGSY for the financial year 2015-16 to the State level implementing agency as detailed below:-

4. This release of fund is exempted from all Treasury restrictions subject to the condition that the account balance out of the amount transferred to any Bank shall not be more than Rs.5 crore on more than two consecutive days.
