ORDER

Pursuant to the Government Order read above, Government hereby make the following amendments to Kerala Financial Code Volume I.

Amendment

(C. S. No: 03/2016)

In the Kerala Financial Code Volume I,

(i) Article 250(1) will be substituted as follows:

‘An advance of ₹ 10,000 will be paid to all Government employees. If a less amount is required, the same will be allowed as multiples of ₹ 1,000 (₹ 500 up to 2012) limiting to a maximum of ₹ 10,000’.

(ii) Below Article 250(1) the following will be inserted:

“(a) As per the conditions prescribed under Note 1 to 3 below, ₹ 2,000 (Two Thousand Rupees only) will be sanctioned to the following categories of employees:

1. Part time contingent employees.
2. N.M.R./C.L.R./Seasonal Workers of all departments, Permanent labourers of agricultural farms.
3. All permanent labourers of Government Departments.

4. Workers in Regional Workshops under PWD, Dredger and Dry-Dock workers in Alappuzha.
 5. Volunteer Workers of family planning.
 6. Anganwadi Workers, Helpers.
 7. Non-permanent workers of Agriculture, Animal Husbandry and Dairy Development Department, Coconut spraying workers of related local bodies and Agriculture Department.
 8. Grass Cutters of Mounted Police Wing.
- (b) The advance will be recovered in five equal instalments in respect of the categories under 1 to 7 and in 21 weekly instalments from the 8th category who receive the wages weekly”.

This will come into force with immediate effect.
